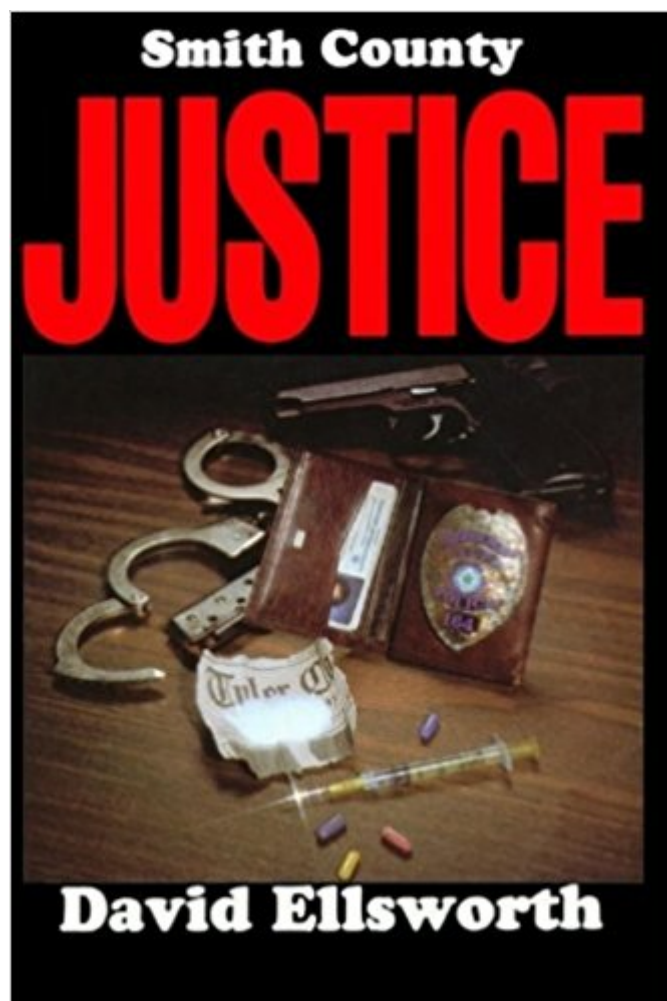

I acquired an electronic copy of this book and could not put it down, not only is there many familiar, respected family's and locations scandalized in this book I quickly found myself immersed in a 1970's Tyler I am too young to have experienced. After reading a few chapters into this book you will feel like you are in Tyler even if you have never previously heard of Smith county. The only real complaint I have with this book is although the events described in this book are unfortunately true, at least a lot of it, the author makes it to clear that he has a personal prejudice against not only this county, but the entire criminal justice system itself. I found myself being forcefully pulled out of this story because of his constant broad political statements that are entirely to aggressive and blatant. Instead of telling it as if this is a neutral investigation letting the readers draw there own opinion, it is as if he decided what the system was like then found a story to perfectly illustrate his preconceived prejudice. It leads one to suspect that some aspects just too conveniently fit his view to be true. So remember when you read this book that he had a political

statement and I suspect he simply left out those parts that did not fit into the picture he was painting. This book seem more like a Micheal Moore or Dan Brown style entertain-umentry instead of a hard hitting investigative nonfiction. Nonetheless it was still a great read that shows that at times the truth is crazier than anything they can come up with in Hollywood. BTW the movie rush is based on the events in this book.
