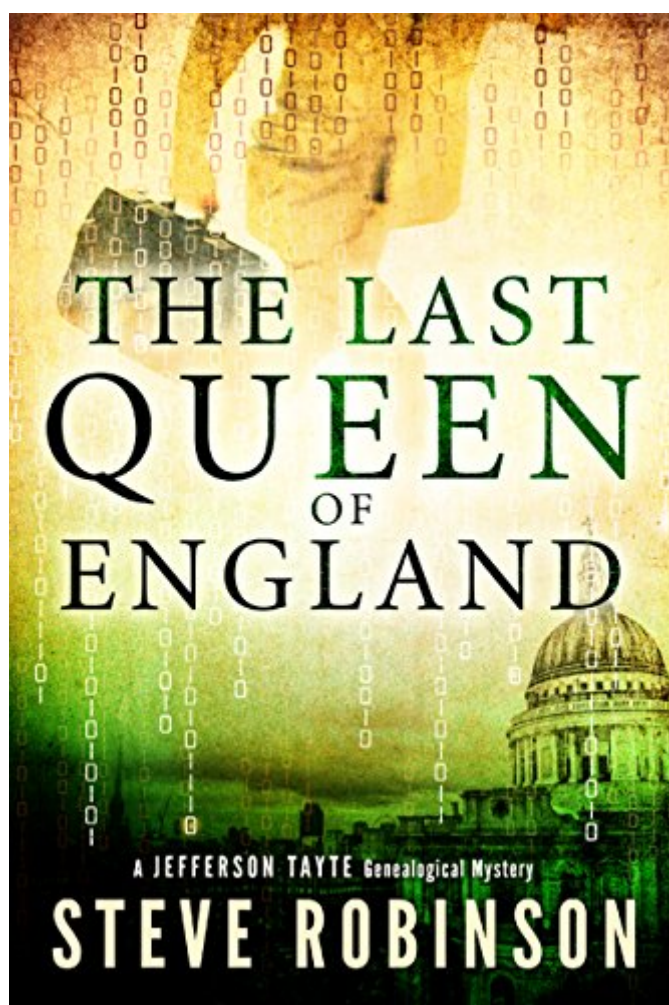

I enjoyed Steve Robinson's first two Jefferson Tayte books but his latest offering is weak and a total

letdown. Tayte increasingly lacks believability and, as I mentioned in my review of the second novel, seems devoid of normal feelings when confronted with murder or attempted murder. Awful things are done to various persons in this novel yet Tayte remains as detached from death or suffering as a hardened Scotland Yard homicide detective. He's an enigma. The author has led us to believe through two books that Tayte is a self-deprecating, overweight bachelor who lives alone, is addicted to chocolate and has no love interest in his life. At forty, he has not yet matured into an adult and his feeble attempt at romance reads like a very bad Harlequin paperback. Yet this chubby chocoholic also seems to possess superpowers; he's able to chase through seventy-two hours without a wink of sleep. Tayte is just no longer believable. To this reader's satisfaction, Mr. Robinson never develops the background or essence of his characters. Members of Britain's MI5 are introduced without thread or reason (other than to mention haircuts and a dogtooth suit). We meet a politician who has no real bearing on the plot and could easily have been left out of the story altogether. A killer emerges, devoid of substance. The killer and his brother are enigmas. Why is one brother a psychopath? What happened in his formative years that made him an insane killer? We don't know what makes them tick or why they are so obsessed with family history. It's not fully explained by the author, therefore the over the top killing spree makes no sense. The villain of the piece is an effete and tiresome Frenchman; we are given nothing of his background in this weak and lukewarm plot.
