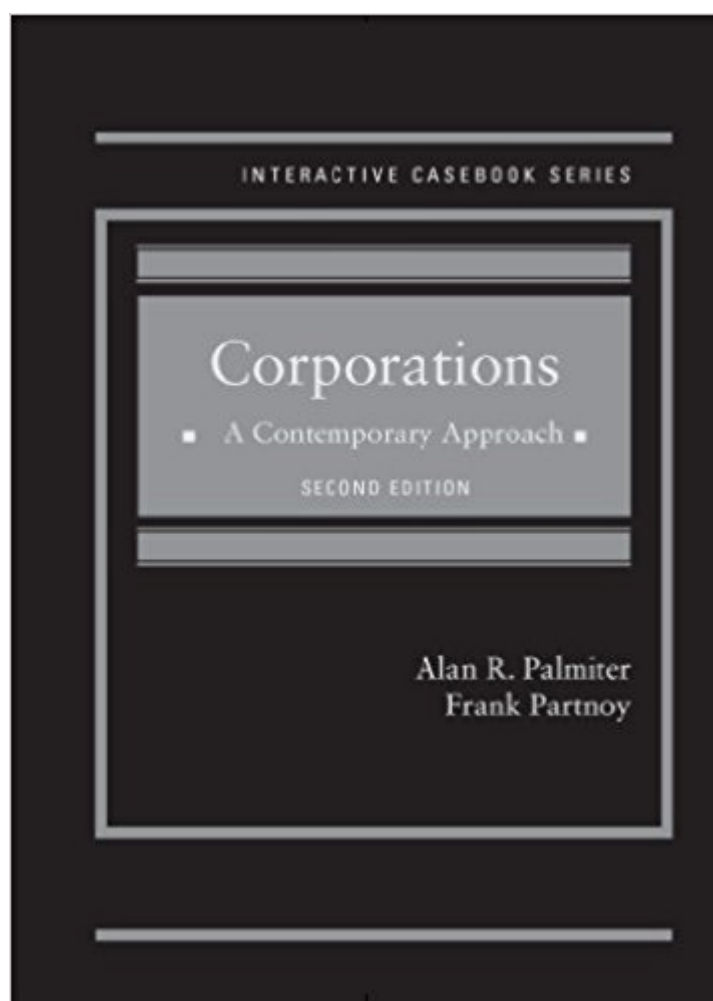

As a law student, I am often frustrated by the disorganization in typical legal textbooks, and I find them to be overly dry and dense - making difficult information even more difficult to understand. This is easily the best casebook I have ever used, and as difficult as this course and my professor were, I learned more in this class than any other class I have taken in law school thus far. I attribute a lot of my learning to the design and layout of this textbook. I would recommend this book to anyone with an interest in corporate law, or to any law student or lawyer who needs to learn this material.

This textbook has the worst editing I have ever encountered in a textbook, both through undergrad and law school. There are identical paragraphs that repeat one after another because it was accidentally duplicated and not edited out and there is a lot of useless information and chattiness to

the textbook that you just do not need when you are trying to read for class. Please read through your own textbook at least once if you expect students to read it too.
