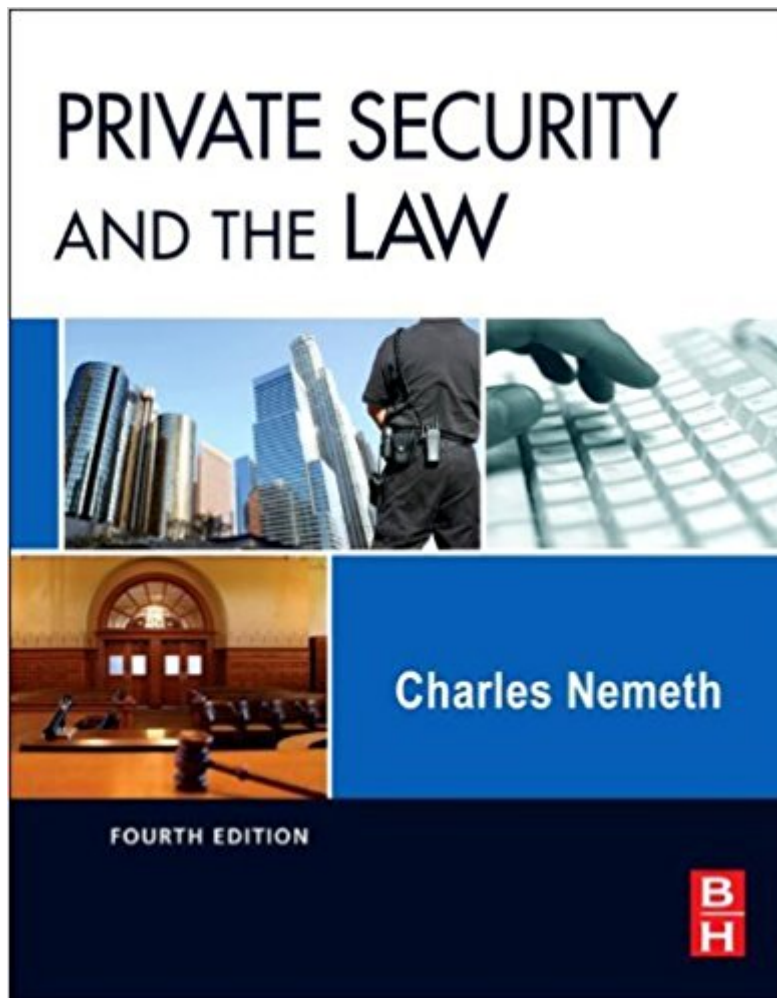

Private Security and the Law, Fourth Edition traces legal developments affecting the private security industry. It examines the industry's staying power and ability to adapt to changes in law enforcement, from street and community protection to the protection of assets, buildings, and people.
