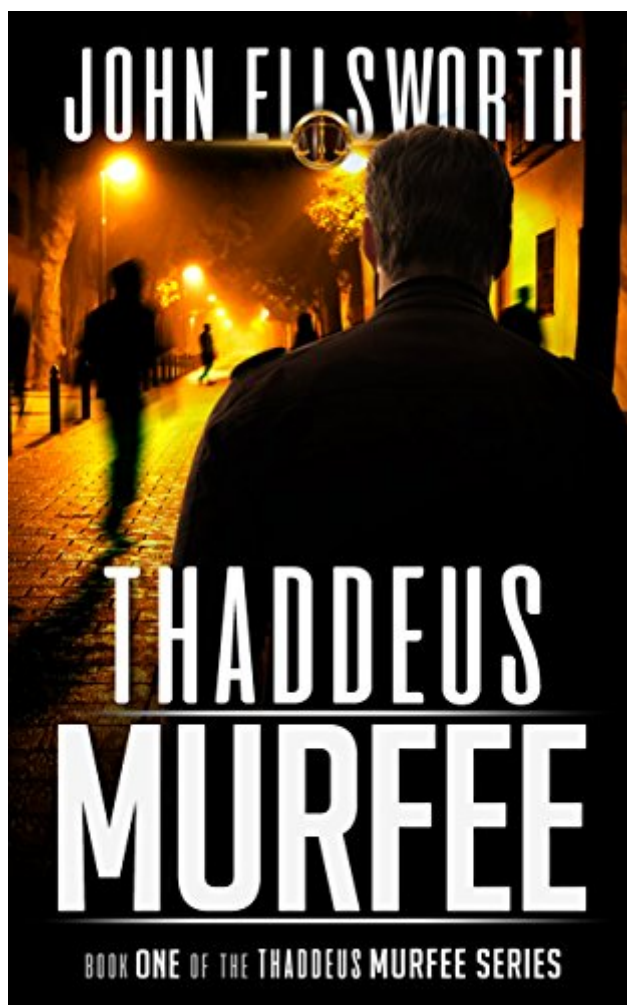

This is a newly-published prequel to a whole series of courtroom thrillers about a Midwestern trial lawyer, Thaddeus Murphee. This one recounts how he, a brand-new graduate of Georgetown University Law School in Washington, D.C., came to establish his practice in the little town of Orbit, in downstate Illinois. It is by nature a convoluted tale, and is based on the rather far-fetched premise that Thad, who finished third in his class, has graduated without even the hint of a job. This, in a city infested with high-voltage law firms. He is finally recruited by the U. S. Attorney's Office in the Department of Justice to become a sort of gatekeeper for a veteran career officer, the better to spy on his activities. There is a suspicion that he is delivering information to the Chinese government. The ins and outs of the plot are too many to outline here, but Mr. Ellsworth seems not to have done much homework on the nitty-gritty of Civil Service employment. Thad's beginning salary is almost congressional, an appalling prospect, and not long afterward it is almost doubled by one of the departmental investigators to whom he is reporting. To this old civil servant, we are in the Land of Oz. Ultimately, Thad, still a complete tyro, finds himself in court, defending his boss against a charge of treason. He is thoroughly worked over by a vindictive judge, but he is not only being advised by his own lawyer, a veteran litigator, but gets some vital support from a surprising source. He emerges triumphant, but is so disgusted by the experience that he decides to leave the government altogether. He unfolds a large map of the U.S., closes his eyes, and drops a finger on Orbit, Illinois. He is on his way.
